AGREEMENT

By submitting this Application, the organization ("Organization") and the person acting on behalf of the Organization listed herein ("Applicant") hereby represent, warrant, and agree as follows:

1. The Applicant is properly authorized to act on behalf of the Organization and to submit this application.
2. The Applicant and Organization shall provide such additional information as may be reasonably requested in furtherance of this application, which may include: (i) the Organization's taxpayer identification number; (ii) evidence of the Organization's tax-exempt status, if applicable; and (iii) a complete and accurate Form W-9; or evidence of an ECF fund.
3. All information provided in the application or otherwise submitted in furtherance of the application and awarding of grant funds is true and correct.
4. All grant funds awarded shall be utilized by the Applicant and the Organization in the manner described in this Application.
5. During the period of utilization of any grant funds, the Applicant and the Organization shall provide such periodic information and may be requested, including financial reports detailing use of the funds by the Organization, a project summary, and a project status update in a form acceptable to the Cleve Cook /Emporia Lions Club Fund.
6. The Organization will use all grant funds in a manner compliant with all applicable laws, rules, or regulations, including the antiterrorist financing and asset control laws, regulations, rules, and executive orders; the USA Patriot Act of 2001; and Executive Order 13224.
7. If awarded grant funds, upon reasonable notice, the Applicant and the Organization will: (i) participate in public service announcements, media interviews, or news releases as may be requested; (ii) allow the use of their names and likeness in any press release, advertisement, or similar publication; and (iii) execute any further releases or consents that may be requested with respect to such activities.
8. The Applicant and the Organization understand that the awarding, administration, and continued funding of any grant funds is at the sole discretion of the Cleve Cook /Emporia Lions Club Fund, and terms and conditions associated therewith may be amended or modified at any time without further notice to the Applicant and the Organization, including the termination or delivery of the grant awards.
