Fund for the Future Endowment Hits Goal

The Fund for the Future, the endowment fund to support the ECF, has surpassed \$1 million thanks to a legacy gift from Curtis McCreary. When ECF Executive Director Becky Nurnberg arrived at the ECF, the fund had a balance of \$436,112.13. While it had grown during Becky's tenure, it was still short of the \$1 million goal. While other legacy gifts pushed the endowment closer to the desired balance, it was McCreary's gift that sent the balance well past the amount. The endowment ended the year with a balance over \$1.3 million.

In addition to assisting with the ECF operations, McCreary's gift will also support the area through grants. Curtis and his wife, Ann, were just like the neighbors we see in our communities.
