Elvin Perkins founded the Emporia Community Foundation (ECF) in 1995 with the help of Barbara Walker, George Osborne, Steve Davis, Carl Didde, and Bob Agler. Perkins and his team believed in creating an easy, efficient way for people with the desire to help the community to do so. The ECF was born to support the community but also to help the supporters avoid unnecessary expenses and the hassle of establishing private funds.

The ECF was established with a \$5,000 gift from Loretta Langley and has grown at a rapid speed over the years. With the recent addition of the Newman Regional Health Foundation, the ECF ended its 25th year with a net worth of over \$36 million as of December 31, 2020. That would not be possible without our amazing donors who believe in the ECF's mission.

While we had a big celebration planned in 2020, COVID 19 had other plans for us. We look forward to celebrating our anniversary with the community in 2021 through the ***Emporia Community Foundation Celebrates*** the week of June 14th.



NET ASSETS AT END OF YEAR





Emporia Area Match Day 2019

In 2019, the sixth Emporia Area Match Day began with the national anthem, and then volunteers from 25 organizations and the ECF went to work. Despite the bitter weather outside, donors were already in line and prepared to support their favorite causes with checks and friendly words of inspiration to those working at the booths.

The total amount distributed to the organizations on Giving Tuesday (December 3rd) was \$286,300.42, which included the money raised from donors, \$60,000 in Matching funds, and \$5,040 in sponsored prize grant support. The 2019 Match Day total added to the previous 5-year Match Day funds brought the overall amount to an impressive \$1,100,720 in six years to 33 local non-profits, beginning with 15 groups and \$20,000 in matching funds in 2014.

The 2019 Emporia Match Day was made possible by the six funding partners for the annual event. They provided the \$60,000 in matching funds for the 25 charitable organizations. The 2019 funding partners included: Clint Bowyer's 79 Fund, the Hopkins, Reeble & Trusler Foundations, the Preston Family Trust, and the WS & EC Jones Testamentary Trust, Bank of America, N.A. Trustee. The match money is pro-rated to match donations calculated in proportion to the total amount raised by individual organizations on Match Day.

Once again, the Capitol Federal, Citizens State Bank, Community National Bank, Emporia State Federal Credit Union, ESB Financial, and Lyon County State Bank contributed to \$100 per class in support of the “Growing Up Giving” project for 3rd, 4th, and 5th-grade classes at the Riverside Elementary School. The 2019 event was a Mini-Match Day at the school prior to the event. Nine Match Day groups set up displays for the students in the school and then the students did research online on all of the participating groups to aid in their decisions. The Kaltenbacher Charitable Fund (a component fund of the ECF) provided \$150 for each of the 4th, 5th

and 6th-grade classes at Chase County Elementary School. The Chase County students came to Match Day and visited each organization to aid in their decisions as to how to distribute their funds. In the afternoon, Americus Elementary School students attended Match Day thanks to KansasLand Bank and the Spade Family.

The number of donors has increased every year and the amount of individual donations also continues to rise. Social media played a large role in the success of Match Day which is evident in online giving.

Emporia Area Match Day 2020

The goal of Match Day is to promote participating nonprofit's projects, passions and raise money for their nonprofit organizations, which is matched with \$50,000 from five generous donors. In 2020, the COVID-19 pandemic restrictions made it difficult at best for many organizations to hold fundraising events to support their programs. However, on November 16th volunteers from twenty-three local nonprofit organizations came together for the seventh annual Emporia Area Match Day hosted by the Emporia Community Foundation (ECF). No one knew what to expect, but when everything was totaled, the Match Day organizations raised a record-setting \$322,035.90 from over 944 unique donors, sponsors, and matching sponsors.

Normally, Match Day is held at the Flinthills Mall where people gather to learn about the organizations and make their donations.

Waiting as long as they could, the ECF finally decided to go to online giving, which had been added two years before. To meet the needs of donors not internet savvy, the ECF set up a "drive-thru" at the west ECF entrance. Donors drove up to ECF's door where they were met by volunteers who collected their donations. Volunteers were kept busy from 9:00 – 5:00 on Match Day with little lag time. All the while social distancing, it was a busy day at the ECF office.

Social media also played an important role in getting the messages out about the participating groups for the 2020 Match Day. The end product was videos featuring participating group representatives. The ECF featured the videos on their Facebook page and YouTube channel and encouraged the groups to share them too. Organizations were also encouraged to hold events and contact their donors prior to the event.

The 2020 Match Day was possible because of the five matching donors who each gave \$10,000 to the event. The ECF is grateful for the \$50,000 in "matching money" from the Clint Bowyer 79 Fund; the Jane and Bernard Reeble Endowed Foundation; the Trusler Foundation; the Preston Family Trust; and the WS & EC Jones Testamentary Trust, Bank of America, N.A. Trustee. The generosity of ECF friends and local businesses in the greater Emporia community provided an additional \$3,425 in prizes and awards. 2020 has been a difficult year for many local small businesses, especially those who were shut down in the spring. The ECF appreciated those able to give and look forward to working with those businesses next year that weren't able to give this year.

Growing Up Giving also had a different look in 2020 in that it went completely virtual. USD 253 3rd, 4th, and 5th-grade classes at Timmerman Elementary were able to study the Match Day organizations online, plus watch the videos. The ECF was grateful to the Capitol Federal, Citizens State Bank, Community National Bank, Emporia State Federal Credit Union, ESB Financial, and Lyon County State Bank who provided \$100 per class for the program. The Kaltenbacher Charitable Fund (a component fund of the ECF) provided funds for each of the 4th, 5th, and 6th-grade classes at Chase County Elementary School, USD 284. And, for the second year, North Lyon County's Americus Elementary School students participated in Match Day thanks to KansasLand Bank and the Gwen and Michael Spade Family. Each class was given \$100 to divide among the deserving

nonprofits. The project teaches the students math, debate, and about their community.

The greater Emporia area is extremely generous as demonstrated by the increase in the number of donors each year, plus the number of individual donations which continues to rise. Social media plays a larger role in the success of Match Day which is evident in online giving. The ECF leadership and staff are grateful for those who care deeply not only with their hearts but also with their wallets for the important work of our local nonprofits. The ECF thanks the combined efforts of donors, funders, sponsors, volunteers, media, and the charitable organizations that contributed to the success of the Emporia Area Match Day.


Scholarships

ECF scholarships are money that has a big impact on students in the community seeking post-secondary education. In 2019, the ECF awarded over \$100,000 to 125 students with scholarships averaging \$800 per student. The schools with scholarship funds at ECF include USD 251 North Lyon County, USD 252 Southern Lyon County, USD 253 Emporia, and USD 284 Chase County. Chase County also offers College Access Funds for students taking college classes while in high school.


In 2020, the need for scholarships was still there, but as with so many things, the process was different. Students submitted their applications online seeking the award of a scholarship. Again, the generosity of the greater Emporia community came through and a total of 140 scholarships were awarded for just over \$115,000, averaging \$821 per student.

ECF scholarship funds are sent directly to the financial aid office at the school instead of the student. If for some reason, the student doesn't attend the selected school as planned, the scholarship money is returned to the ECF fund where it originated. ECF scholarships are awarded for a variety of reasons such as need, scholastic average, area of interest for the student, students of diversity, or memorials. Keep It A Safe Summer Event

Flooding conditions in 2019 resulted in the Keep It a Safe Summer (K.I.S.S.) event moved to the Flinthills Mall from the Lyon County Fairgrounds. The change of location did not diminish the steady stream of people attending the event. Thanks to a Sadie Jones Fund grant, kids were able to choose a bicycle helmet or a disc golf package with a total of 400 bicycle helmets and 300 disc golf packages distributed. Families also learned about local activities for a fun and safe summer while enjoying 1,200

hotdogs, fruit, and drinks. Over the years, the Sadie Jones Fund has ensured safe, fun summers for local kids by distributing 7,500 bicycle helmets and 500 golf disc packages. K.I.S.S has been an annual event giving the signal to area kids that summer has begun.

Regretfully, like so many 2020 events and activities, K.I.S.S. was canceled due to the COVID-19 pandemic. Plans are to host the event in 2021.
