## TYPES OF GIVING



### ★ DESIGNATED GIFT

A gift may be made to establish a fund with the income or corpus, or both, to be distributed to a named organization for a charitable purpose, and will serve to benefit that organization anywhere in the world.

### ★ FIELD OF INTEREST GIFT

A gift may be made to establish a field of interest, such as "elementary education" or "performing arts." The foundation, through its governing board and with the cooperation of its grant committees, directs the gifts from that fund to the stated field of interest.

### ★ DONOR-ADVISED GIFT

A donor may make a gift to establish a fund and provide that the donor--or a person designated by the donor--may advise the use of the income or the corpus, or both, from that fund.

### ★ UNRESTRICTED GIFT

A donor may make a gift without restriction for its use, in which case the governing board may use the fund for the purposes of the CCCF as it sees fit.
