MATCH DAY 2021

Another Record Broken

The 8th annual Emporia Area Match Day event was a resounding success, culminating with the 25 participating organizations receiving \$455,703.96 during a check presentation at the Flinthills Mall on November 30th. For the first time ever, a single organization received a larger check than the proceeds from the first Match Day event in 2014. In the last eight years, over \$1.8 million has been awarded to 39 area organizations.

The \$60,000 matching pool for this year's event was contributed by the Clint Bowyer 79 Fund, the Jane & Bernard Reeble Endowed Fund, the Preston Family Charitable Fund, the Trusler Foundation, W.S. & E.C. Jones Testamentary Trust, and Nick & Jan Laurent/Fred & Paula Neuer.
