# MESSAGE FROM THE ECF PRESIDENT JEFF WILLIAMS



This was my first year as President of the Emporia Community Foundation (ECF), and the impact of the ECF in the seven counties we serve - Chase, Coffey, Greenwood, Lyon, Morris, Osage, and Wabaunsee - never ceases

to amaze me. I continue to be inspired by all the accomplishments of the ECF and amazed by the generosity of the people in our area. The ECF has grown in twenty-eight years from the original donation of \$5,000 from Loretto Langley, a school teacher in Olpe, to over three hundred fifty funds today and assets totaling over \$37 million. The ECF uses UMB as our primary financial advisors, and the Finance and Investment Committee, led by ECF Treasurer Janis Meyer, CPA, meets with them quarterly. UMB reported that while the ECF portfolio was down by 11.46% in 2022, in comparison, the S&P 500 ended the year with a loss of 18.11%. Overall, the ECF portfolio outperformed the benchmarks as outlined in our financial policy. I appreciate the volunteers who serve on the ECF Finance and Investment Committee, working with UMB to ensure the best return possible.

A favorite time of year for me is when committees meet in the spring to review applications and award university, technical college, and college access scholarships to area high school students. In 2022, the ECF awarded one hundred eighty-three scholarships for students continuing to higher education all over Kansas and the United States due to the generosity of donors who see the future in our area students. The 9th annual Match Day in 2022 was a huge success, hosting twenty-eight organizations and raising over \$500,000 for area groups. To

be considered for the 2022 Match Day, an organization had to have an operating budget of \$175,000 or less and be located in one of the seven counties served by the ECF. Leading up to the big day on November 14, 2022, the ECF staff worked with the organizations producing videos for each group as well as individual web pages on the Match Day website and information on fundraising. A highlight was Growing Up Giving, in which twentyseven area classrooms were allocated \$100 in Match Day dollars per class. The students then studied the groups, dividing up their money where they saw fit. All the efforts were worth it when the checks were awarded on Giving Tuesday at the Flinthills Mall in a live presentation on KVOE. A total of \$2,380,325.97 has been gifted to forty-eight area smaller non-profits through the Match Day program in just nine short years. The generosity of the greater Emporia area is remarkable!

As the ECF looks to the future, we are now focused on the Flint Hills Legacy program. A Flint Hills Legacy Fund allows your assets to remain in your control during your lifetime and then provides support for the programs you care about after you pass. Legacy funds offer flexibility in that they can be modified depending on circumstances by simply meeting with ECF staff. Many have also funded Donor Advised Funds to impact causes now. Plus, there may be significant tax savings. Flint Hills Legacy Funds benefit the greater Emporia area far into the future. In looking back on 2022, I extend my thanks to the ECF Board of Directors, the ECF Trustees, the many volunteers and the ECF Staff for such a successful year. ### **2022 EMPORIA AREA MATCH DAY**

The 2022 Emporia Area Match Day was held on November 14th, the 9th year of the annual event. It proved to be yet another record-breaking year, crossing the half-million dollar mark for the first time, soaring past the previous record. This year's Match Day raised an astonishing \$501,865.62 across twenty-eight participating organizations. Team Schnak Strong received \$84,305.07, the most ever raised by a single Match Day organization.

#### LEGACIES

Our legacy is a perception - an idea about what we hope to leave behind.

Our legacy reflects our mission or life purpose.

Our legacy is a summary of who we were, how we will be remembered, and perchance ---- what we leave to others in the future.

The Flint Hills Legacies is an Emporia Community Foundation (ECF) program made up of people passionate about the greater Emporia area and who want to provide an ever-improving quality of life for generations to come. When someone starts a Flint Hills Legacy Fund, they join like-minded people committed to supporting the needs of the community that holds a piece of their heart.

One of the latest fund agreements to be fulfilled with the ECF is the Anna Mae Grimmett Legacy Fund. Anna Mae grew up in Madison, Kansas and moved to Emporia when she was young. For many years, she had a professional house cleaning business in the area with her sister, Wilma. When her husband, Cleo (Bud) Grimmett, retired in 2004, they pursued their love of cattle and being outdoors on their pasture land around the Olpe area and northwest of Emporia.

After Bud passed in 2013, Anna Mae established an Endowed Legacy Fund with the ECF. The fund allowed Anna Mae access to her assets to pay for assisted living expenses, and upon her passing in 2020, assets that were left went into this fund. When her estate was probated, her remaining assets were sold, which included land, a couple of older model cars, a John Deere tractor, and some CDs. This resulted in Grimmett ECF Endowed Legacy Fund. This fund will provide support for programs benefitting animals and their owners within Lyon County for years to come.

## **SOYBEANS AND EXPUNGEMENTS**

Expungement is the process of removing a record of criminal conviction, to be treated as if it had never occurred. This is assuming certain time limits and behavioral conditions are met. Some of the requirements of an expungement are a filing fee and other additional costs which can be difficult for qualifying individuals to secure along with other costs of daily living.

Richard Porter, owner of Porter Cattle Company in northern Lyon County, had personally helped with the expungement for two individuals in his area and literally saw life changing differences for them and their families. Porter decided to help others facing similar circumstances here in our community and across the state as he has done previously and he contacted the ECF for help. As he's done in the past, Porter donated soybeans raised on his farm to the ECF to fund an expungement program.

Porter delivers the soybeans to the Miller Elevator with instructions that the ownership is to be transferred to the Emporia Community Foundation. The soybeans are sold that day and a check for the proceeds is sent to the ECF. By donating commodities such as soybeans, corn, wheat, hay, and cattle; farmers and ranchers can

deduct the production expenses and not declare the income when filing taxes. The proceeds from the commodities are then available for use in various projects, programs, and organizations, like the expungement program.

The ECF connected Porter with the Kansas Legal Services (KLS), a non-profit law firm and community education organization that helps low- and moderate-income people in Kansas. Porter's soybeans have paid for educational seminars and expungements for Lyon County residents and others across the state of Kansas. The resources from those soybeans have helped to reshape the lives of many who were prevented from escaping their past due to the inability to pay the fees associated with an expungement. From soybean fields in northern Lyon County to courtrooms across Kansas, the generosity of an individual is paying off in a renewal of many lives and their families.
